MEMORANDUM FOR THE ASSISTANT SECRETARY OF DEFENSE (I&amp;L)

SUBJECT: Kent Island Research and Development Project (U)

1. The Research and Development project planned for Curtis Bay was not implemented and the Land lease permit provided the National Security Agency has been terminated. The cost estimate (\$350,000.00) prepared by the Baltimore District Engineer as a part of the preliminary design for the Curtis Bay project was not economically feasible. A survey was conducted to find another site which could be economically developed. Such a site was located at Kent Island, Maryland, and the Washington District Engineer has obtained a very favorable five-year renewable lease.

2. It is requested that permission be granted to develop the Kent Island site in lieu of Curtis Bay. An architect-engineer has rendered an engineering report on Kent Island and has estimated a total cost of \$150,000.00 for the development of this project.

3. National Security Agency FY-61 RDT&E funds in the amount of \$50,000.00 will be used to implement this project. The first portion of the project consists of a power line, new road, siting and construction of a 20' x 40' nonconductive (concrete masonry) building. A non-conductive building is essential for the effective accomplishment of the project. The remainder of the project consisting of clearing, grubbing and soil stabilization may be accomplished at a later date.


