#### A5-20 AS-14 22 Aug 47 Disposel of SICSALY Equipments

- 1. Attached hereto are two papers, one from AS-70, the other from AS-60, dealing with the question of the disposition of the SIGSALY equipments now stored in the basement of the 4th Wing, "5" Building. The interest of AS-70 in the matter arises from the needs of that Division for additional space for its own work in the development of electronic analytical equipment as well as for meeting the space requirements for analogues which are to be operated by AS-70 on behalf of AS-90. The interest of AS-60 in the matter arises from a consideration of the difficulties being encountered in the terms of an agreement made tetween ASA and the Chief Signal Officer in respect to the SIGSALY equipments.
  - Covernment, and every effort should be made to salvage as much as possible of this investment. The terms of the agreement of reference were, in substance, (1) to keep and maintain six SIGSALY equipments so that they "could be reconditioned and utilized in the shortest possible time in the event of a national emergency;" and (2) to destroy the remaining six terminals. The first condition, rehabilitation of six terminals, cannot be met because our engineers assert that it is uneconomical to rehabilitate these equipments either now or at any future date. Further, they assert that it would be cheaper and more practicable, in the event of emergency, to manufacture entirely new equipments either identical in design with the ones used during World War II or of a design incorporating already made or expected advances in the art (AN/GSQ-2).
  - b. The foregoing conclusions reached by our own engineers should as checked by outside engineers before taking up with outside agencies any questions concerning the disposition of the SIGSALY equipments.
  - c. If the conclusions reached by our own engineers are corroborated, the Chief Signal Officer should be advised thereof and asked to agree to an abrogation of the original agreement, thus clearing the way for a destruction of all twelve equipments.
  - d. If the Chief Signal Officer does not concur, then the matter should be brought to the attention of higher authority with

- 1. a view to having the Chief, ASA relieved of his responsibility in the matter and having some other agency take it over, including removal of the nine equipments at this station as primptly as practicable. (Following are present locations of the other three terminals: two in Room Its 1030 in the Pentagon, one at New Cumberland Signal Depot. These should also be released from oustady of ASA and at least the one at Nov Gumborland removes therefrom.)
  - a. If, however, the Chief Signal Officer should concur in · abrogating the agreement, all the equipments should be declared obsolete and their disposition should then be directed. They could be declared surplus property, thereafter to be taken over by MAA and sold, but this course is inadvicable. Pirst, it would require that a complete inventory be made by ASA, a job that would take months and require the services of competent personnel not evallable for the purpose. Second, it would involve the Government in local tangles because not all of the components belong to the Government: pertuin ones are leased from the Fell Laboratories. Third, it you'll deprive ASA of an excellent scurce of meterial utilizable by AS-70. **AS-80.** and AS-90.
    - 3. It is recommended that the following steps to taken in the disposition of the equipments:
    - s. Consult first with Dell Laboratories, the original contractor, to accertain if that firm would be interested in undertaking a contract for rehabilitating six terminal equipments and ascertaining the approximate cost thereof. It is highly probable that this firm would not be at all interested in such a contract and would reach the same conclusion with respect to the practical flity and economics of such a proposal as has been reached by our own engineers. This step would at least serve as a confirmation of the opinion of our own engineers and the results thereof could be used in presenting the case to the Chief Signal Officer or higher authority.
    - b. Assuming that the probable result predicted above turns out to be an actuality, then ask the Bell Laboratories to indicate what components are leased, terminating the lease, and returning those components to the contractor. The indications supplied by the contractor could be checked against the contract more readily in this manner than if our own personnel tried to ascertain the necessary information initially from a study of the contract.
    - c. Although all cryptographic components have been removed from these equipments, the latter are still classified as SEORET, and this classification should be maintained, in conformity with the G-2 directive on the release of cryptographic principles, because the whole assemblage of non-classified components makes up

- 1. a system not solvable by us. A decision to maintain for an indefinite period the present classification of the equipment, and of any patent applications involved therein, should be communicated to Bell Lauoratories for their information.
  - d. As in the case of Converter M-209 and Ciphor Device M-138, the SIGSALY equipments should be classified as Military Type Items. This sycids the necessity for declaring them surplus property. For Lisposal by War Assets Administration. Disposition by destruction can then be authorized.
  - equipment is granted to the chief of the technical service responsible for ... the design, development, test, or production or procurement of such equipment (see Par. 662 of AR 388-5). At the time the SIGSALY equipments were constructed, the chief of the technical service responsible for the design, development, test, production and procurement of those equipments was the Chief Signal Officer; but at this time the responsibility for the things mentioned clove, in connection with "non-integrated" communication security equipments, rests wholly with the Chief, Army Security Agency. Presumably, therefore, the latter could authorize the destruction of these equipments without consulting the Chief Signal Officer. Revever, in view of the interest of the Chief Signal Officer in these equipments and the existing agreement concerning them, it is recommended that the concurrence of the Chief Signal Officem as well as that of the Directors of Intelligence, SS & P, and P & O of the War Department General Staff, he obtained in this matter.
  - f. Having obtained the necessary authorization, destruction should be accomplished in accordance with the provisions of Par. 66b of AR 380-5.
  - g. In the course of the destruction, it may be found quite practicable to use the equipments as a source of parts and components for AS-70, AS-80, and AS-90. The remainder can then be turned over to the Post Conservation Officer for disposition. While the stripping of these equipments to obtain utilisable items may take some months, it can be accomplished to the advantage of the Government in view of the value of the salvageable items which can easily be obtained in this manner and which are either difficult

- or costly to obtain by purchase. It is estimated by AS-70 that
  the services of two men for a period of six weeks would be required
  for the purpose of removing utilization spare parts and stripping
  the cabinets of such components or Items as can readily be used
  here. This estimate does not include inventorated for accounting
  purposes.
  - h. As the stripping progresses, the remaining items should be moved into more compactly occupied space and the space made seallable thereby be turned over to AS-70 in increments as they become available.
  - 1. At such time as is convenient, the same operations should be conducted with regard to the two terminals at the Pentagon and the one terminal at New Cumberland.
  - i. The drawings and blueprints pertaining to the equipments, now in about eight 4-drawer filing cases, in the basement of Wing 4, cheuld be stored in the basement of the Cafeteria or shipped to Lev Cumberland.
  - 4. The foregoing recommendations have been coordinated with AS-70 and AU-CO, and meet with their concurrence.
