Subject: Request Concerning U.S. Synoptic Weather Forecasts.

6. It is considered that the security risk in this case is justified and is acceptable. It is, therefore, recommended that USCIB approve the procedure outlined in paragraph 4 above.

7. Although the date for the intended amphibious operation is not known, it is believed that it will be conducted in the near future. It is therefore requested that USCIB consider this proposal as a matter of urgency.

8. The Joint Intelligence Committee has requested me to submit the above proposal to the United States Communications Intelligence Board for consideration. It is further requested that the response of the Board be addressed to the Secretary, Joint Intelligence Committee.
