I so confident that you will be fully prepared to say, "We are ready for direct chipment of spare perts (past the depots) to our customers.")

## 7. DCS/P

Reported that the two invercept sites in desired by ASA cassot be made available and that further surveys will be necessary.

#### 8. SCHOOL

Advised that a rapid course of training in Hungarian, Czech, and Folish was being conducted at the School to provide linguists for ASA Europe in the shortest vessible time.

#### 9. TRAINING

Announced that four persons, all from MSA-70, have been selected from MSA to perticipate in the Third Career Development Program of the Civil Service Commission.beginning 1 February 1956, for a five-month period.

#### 10. SECURITY

Stressed the need for the immediate reporting by Chiefs of Offices and Staff Divisions of incidents requiring investigation by SEC. (The Director supported this request and stated, "We are trying to become professionals in the non-technical portions supporting the main mission of the Agency. Our Security organization has gradually been devoloped into a very professional cutfit. Give them the same treatment that you would any other professional unit.")

#### 11. PERSONNEL

Stated that DA has published a directive on the Contingency Option Act and the Navy and Air Force will also be preparing a paper, and that as soon as they are published, PERS will determine their respective differences and discombate this information to Agency personnel.

## 12. SPECIAL ASSISTANT (Capt. Holtwick)

Informed of his progress in the pursuance of operational research statistics and remarked that COF is currently working on this in order that the work measurement program and statistics for labor distribution will be compatible and either may be used.

# 13. HEADQUARTERS COGNANDART

Reported that the modifications of Remington-Rand safes were proceeding at a rapid rate to climinate their security wasknesses.

# 14. COLLECTION

Stated that MBA-63 exchines were in operation on the third floor of Bldg. 17, MBS, 18 January, after the week-end move.

Remarked that the Defrost equipment will prove to be a very satisfactory device, and it is a long step forward in the reduction of the size and volume of MEA-70's files.

## 16. DIRECTOR

The Director concluded the conference with the following statements:

"I find that there is some confusion as to whether I am a stend-patter or a new-dealer or where I may happen to stand. Technically, I was assuming that you would realize by this time that I buy only tomorrow. I believe in changes technically at the instant that we can demonstrate that they are an improvement. If you wait for a perfect solution, you will never adopt it.

"Now as to non-technical matters, there is a tremendous difference between the technical aspects of a problem and the philosophy behind the problem. It is not a person when sembody is using temperow's equipment on yesterday's philosophy. The basic philosophy of the world doesn't change as rapidly as the man who invents translators or better cost-accounting.

"On the question of technical progress, you have got to look at your technical methodology every day. It must be under constant review to be sure that it is togerrow's techniques and not yesterday's. We don't have to review our philosophy nearly that often."

The Director made reference to newspaper publicity sematimes received by NSA, and stated, "It is useless for us to try to hide our heads in the sand and say, 'Look, nobody knows what we are doing.' I say that we will get along much better with the newspaper people if we don't complain when one of them says, 'That Agency out there on Nebraska Avenue is in the codes, ciphers, and intercept business.'"

"There are two things about which we must maintain absolute secrecy: one is the particular type of thing that we are doing, and the other is how we do it."
